We would like to bring the following few lines for your kind consideration and favourable orders. Chinmaya Grameena Vidyalaya is established in the year 1992 in our Sandeepany Ashram, Chokkahalli which is 7 KMS from KOLAR District Head Quarters. The above school is started with a view to give good education to rural students. Presently students from Pre KG to 10th Standard are studying in the school. Secondly, we started Chinmaya Independent Pre University college in the same premises ie., Chokkahalli during 2015 and since then 11th and 12th standard students are studying in the college. Both the institutions are run under state Government educational board norms, conditions, and syllabus.

Having being given to understand that the Central Government new Educational Policy is a Comprehensive educational system and applauded by many veteran educationists, our School Committee decided to adopt the CBSE education system in place of state Government system of education. In the first phase, the committee decided to convert the present Chinmaya Grameena Vidyalaya to CBSE pattern and accordingly, we obtained no-objection certificate from the Karnataka State Government and applied for affiliation to CBSE board through on-line. The school will be named as Chinmaya Vidyalaya (CBSE), once obtaining affiliation.
