Name of School: Since we moved the application for NOC through our Chinmaya Grameena Vidyalaya, the Govt of Karnataka has issued NOC mentioning the school name as Chinmaya Grameena Vidyalaya. We request to accord affiliation in the name of Chinmaya Vidyalaya (CBSE).

Name of Principal/Head of School: Sri K Jayaraju has retired on Superannuation and hence Sri R. C. Manjunath has been appointed as New Principal to proposed Chinmaya Vidyalaya (CBSE).

Educational/Professional Qualifications: Though Mr. R C Manjunath has submitted MA marks card CBSE, requirement calls for certificate. Sri R C Manjunath has been informed to submit Degree Certificate. The same will be uploaded as soon as we receive.

Administrative Experience: Since Sri. R C Manjunath has replaced Sri K Jayaraju, the present Principal's experience is uploaded. In addition to 6 years administrative experience Sri. R C Manjunath has got 15 years teaching experience.

Standard/level/class up to which the school is running: Presently the school has obtained Recognition from Class 1 to Class 8.

Location of School: There was no scope in the CBSE format to mention Gram Panchayath location. Since Chokkahalli comes under Kolar Taluk the earlier information was furnished.

Is the school situated on a single contiguous plot of land bounded on all sides by a Boundary Wall (Approx. 6 Feet): Since the school is situated within the vicinity of Sandeepani Ashram the entire Ashram boundary is fenced.

Total area (in square meters): By oversight the area has been mentioned in Sq foot instead of Sq meters. The actual area as per registered document works out to 14,164.01 Sq Mts (3.5 acrs)

The land is in the name of the School/ Trust/Society/Company legally by way of: The land is in the name of our Trust namely Karnataka Chinmaya Seva Trust. If provision is made, the kannada version and translation will be uploaded.

NOC: It may please be noted that the Education Department, Commissioner recommended and forwarded the application to the Govt on 20 Sept 2019. After thorough examination the Karnataka Govt Secretariat has issued certificate on 20 Feb 2020.

Recognition Certificate: After the submission of application several Recognitions have been renewed and the same renewed recognition certificates have been shown to IC.

Building Safety: The Inspection team visited the spot on 02 Dec 2020. After submission of the inspection report and observing all formalities the issuing authority has issued the certificate on 15 Dec 2020.

Fire Safety: As per the new policy the Fire Safety has to be renewed every year. Accordingly we will renew the Fire Safety recognition.

DEO: In place of self certification we will upload the proforma with DEO signature. Please make provision to upload the same.





